







PRINCE GEORGE'S COUNTY COUNCIL SESSION CLEAN WATER PARTNERSHIP FY19 OVERVIEW

The Clean Water Partnership

• A 30-year partnership between Prince George's County, Maryland and Corvias to identify, design, build, finance, operate and maintain stormwater assets.



- Based on the Community-Based Public Private Partnership (CBP3) model as developed by the USEPA Region III.
- Intentionally developed to provide multiple, overlaying benefits (socioeconomic, environmental, implementation efficiency, local uplift, compliance surety).



Stormwater can be an impactful infrastructure program that achieves broader County policy goals and objectives:

- Achievement of greater cost savings, innovation, efficiencies and economic development output are possible across County infrastructure programs
- More effective utilization of a partnership treating it less like an environmental contractor and more like a partner in its overall infrastructure strategy
- Can increase efficiencies and job creation opportunities by <u>NOT</u> duplicating efforts across CIP, DPWT & CWP, leveraging the established subcontractor capacity & workforce development programs across all of them
- Improvements to the funding strategy that reduces pricing and allows for flexibility in procurement that creates opportunities for SMWBE firms to grow



Performance Based Results:

- 131 projects completed across nine County Council districts in 54 months to date
- 2,236 acres retrofitted for MS4/TMDL permit compliance
- Local Economic Impact
 - 85% (\$111M) Total Expenditures to Target Class Businesses
 - 57% County Resident Work Hours
- Community Impact
 - 22 Faith-based retrofits through the alternative compliance program (ACP), 54 school projects through the partnership with Prince George's County Public Schools, and 28 retrofits on municipal property throughout the County
 - Over \$500,000 invested in community partnerships i.e. youth and environmental literacy programs, 25 Mentor Protégé Program participants and paid internships for over 50 Prince George's County students
 - Greening and beautifying our landscape planting 417 trees and 12,294 shrubs and improving our local rivers and streams removing over 27 million pounds of sediment and 8 tons of tons of trash
