### SITE ACCESS INFO:

There will be approximately 5-10 vehicles on site, hauling materials to and from the pond daily.

Construction crews will access the site via Manderes Place. All construction and staging will occur within the project's limit of disturbance (LOD). The LOD is the boundary within which all construction, materials, storage, grading, landscaping, and related activities will occur.

# **CONSTRUCTION PARKING INFO:**

Crews will park vehicles in the cul-de-sac on Manderes Place or within the LOD. Parking on Manderes Place will be restricted during construction hours to allow trucks to enter/exit safely and to avoid vehicle damage.

### PEDESTRIAN ACCESS INFO:

The pedestrian path will be closed during this project.

### TREE REMOVAL:

As needed, the contractor will remove trees to establish access and make room for construction. Efforts will be made to minimize tree removal and preserve trees where possible. Trees and vegetation will also be cleared around the outfall located on the east side of Heidi Lane. However, Heidi Lane will remain open during construction. Disturbed areas will be re-stabilized with grass. Additionally, invasive vegetation will be removed and replaced with native plants and shrubs.
